

## Terms of Use:

### General

Benjamin Ryan Productions, LLC ("BRP") produces and operates YourNewHomeChicagoTV.com ("YNHC"). Any person accessing or using the YNHC is referred to as "you"

### Acceptance of Terms

By accessing or using any part of YNHC or the services provided on it or other Web sites as set forth below (collectively, the "Services"), you agree to accept and comply with the terms, conditions, and notices stated herein and as may be modified by BRP from time-to-time without notice to you (the "Terms of Use"). These Terms of Use constitute a binding contract between BRP and you. You are responsible for regularly reviewing the Terms of Use. If you do not wish to be bound by these Terms of Use, please do not access or use any part of the Site.

### General Use of YNHC

Unless specified otherwise, BRP offers you access to YNHC solely for your personal and non-commercial uses. You agree to only access or use YNHC only for legal purposes that are permitted by the Terms of Use. Among other things, you agree not to:

- intentionally or unintentionally violate any applicable local, state, national or international law, or any regulations having the force of law, including the Civil Rights Act of 1866, the Fair Housing Act, the Americans with Disabilities Act, and the Equal Credit Opportunity Act.

Applicable Law

This Terms of Use is governed by the laws of the State of Illinois, U.S.A. without regard to conflicts of laws principles. You hereby consent to the exclusive jurisdiction and venue of courts sitting in Illinois, County of Kane in all disputes arising out of or relating to accessing or using YNHC. Access or use of YNHC is unauthorized in any jurisdiction that does not give effect to all provisions of these terms and conditions, including without limitation this paragraph.

You agree that no joint venture, partnership, employment, or agency relationship exists between you and BRP as a result of the Terms of Use or accessing or using YNHC.
